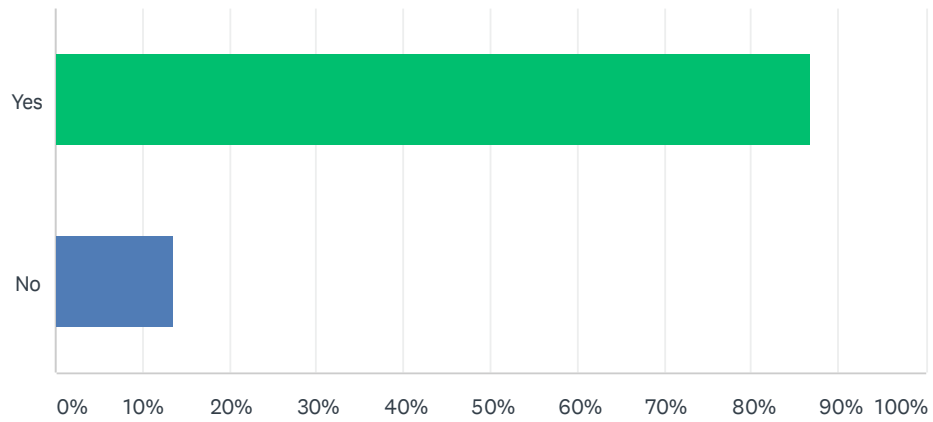


# Q1 Have you received financial support from the UK Government during the Covid-19 crisis?

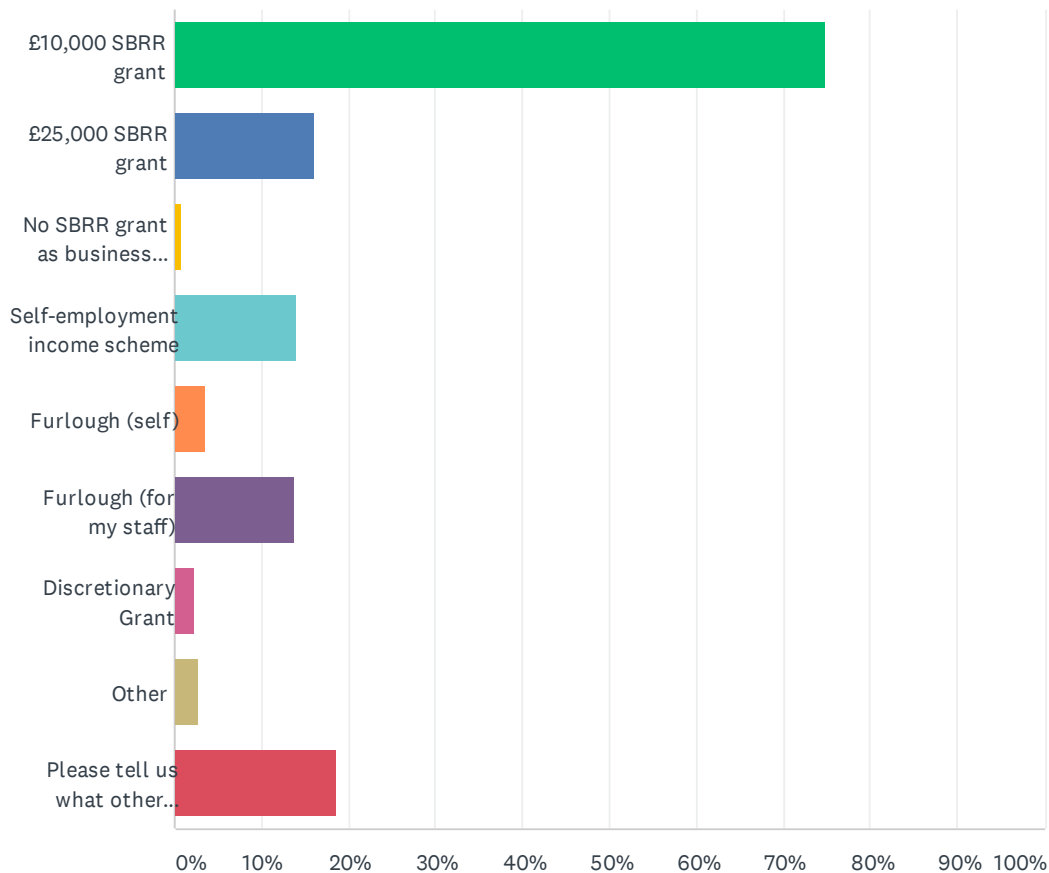

## Q2 If yes, did you receive any of the following (tick all that apply)

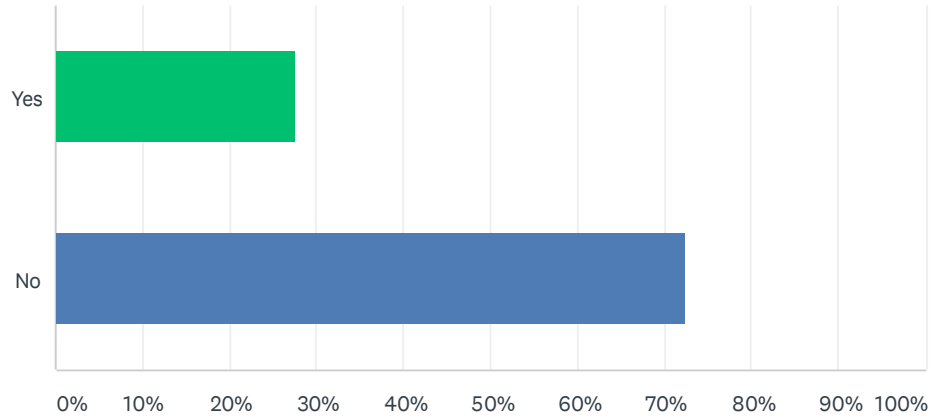

### Q3 Have you applied for a Business Bounce Back Loan?

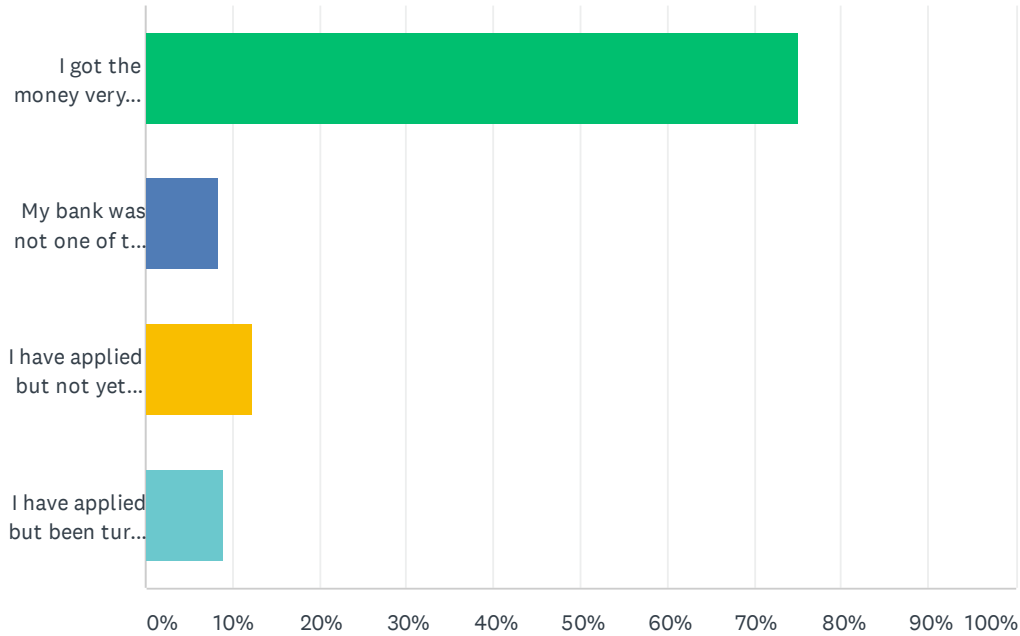

### Q4 If yes, which of the below best represents your situation (tick all that apply)

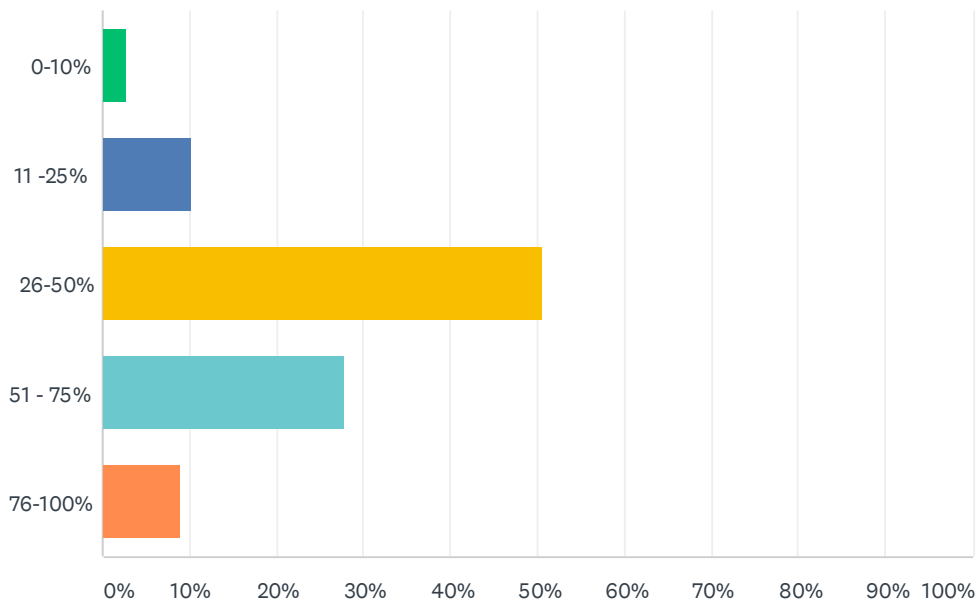

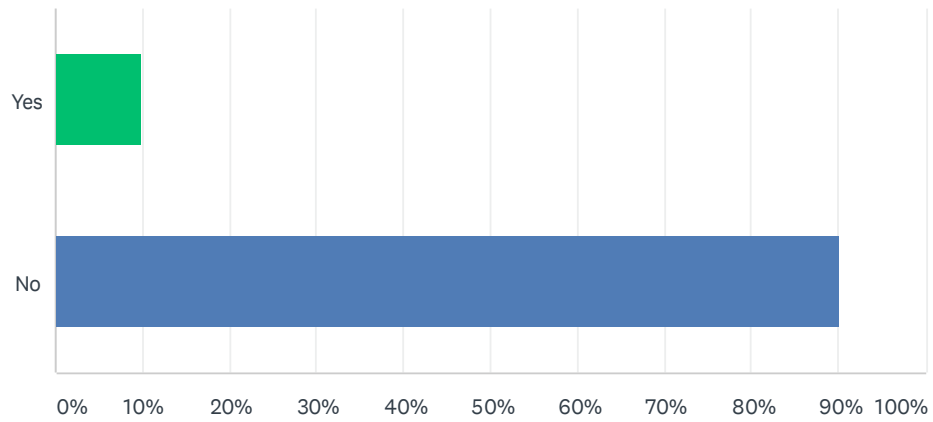

## Q6 Business Interruption Insurance: have you had cover confirmed at this point?

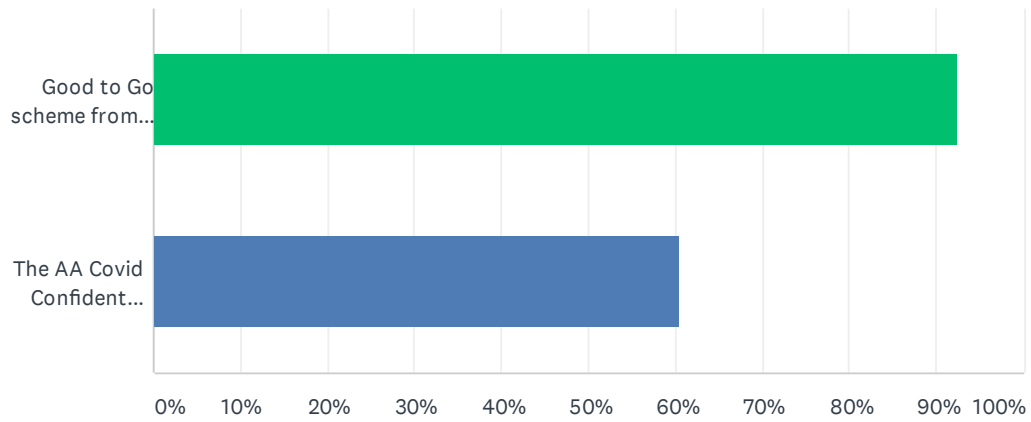

## Q7 Opening up accreditation: will you be applying for any of the following? Tick all

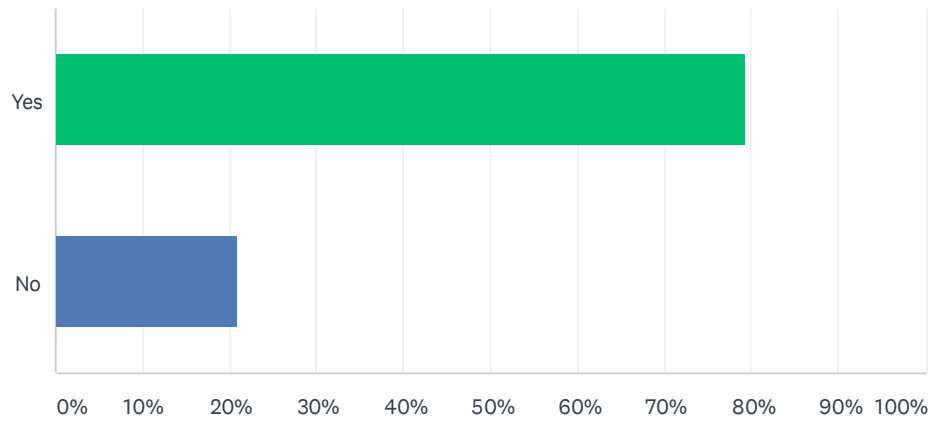

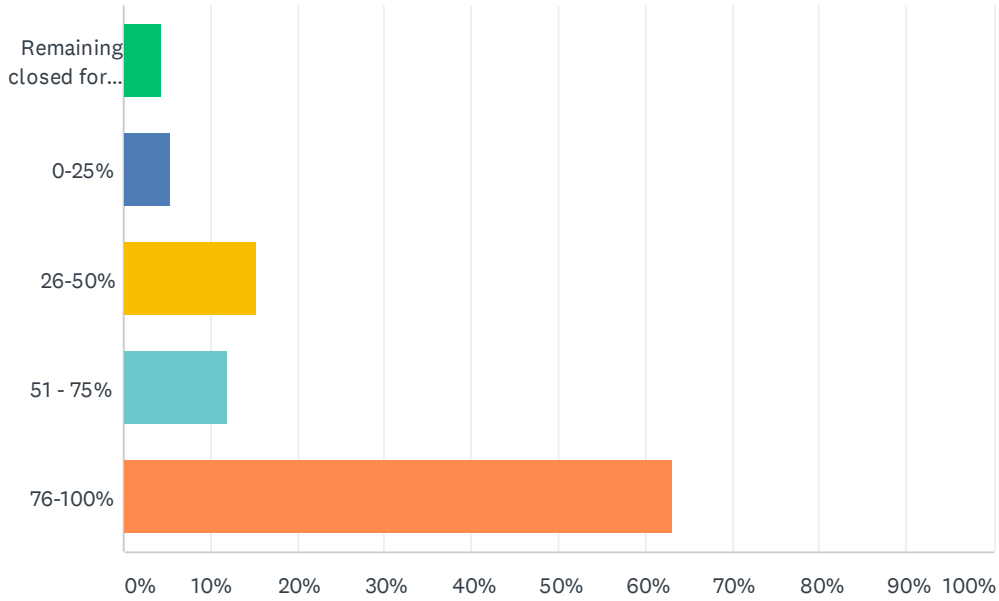

### Q9 At what capacity will reopen initially? Tick one

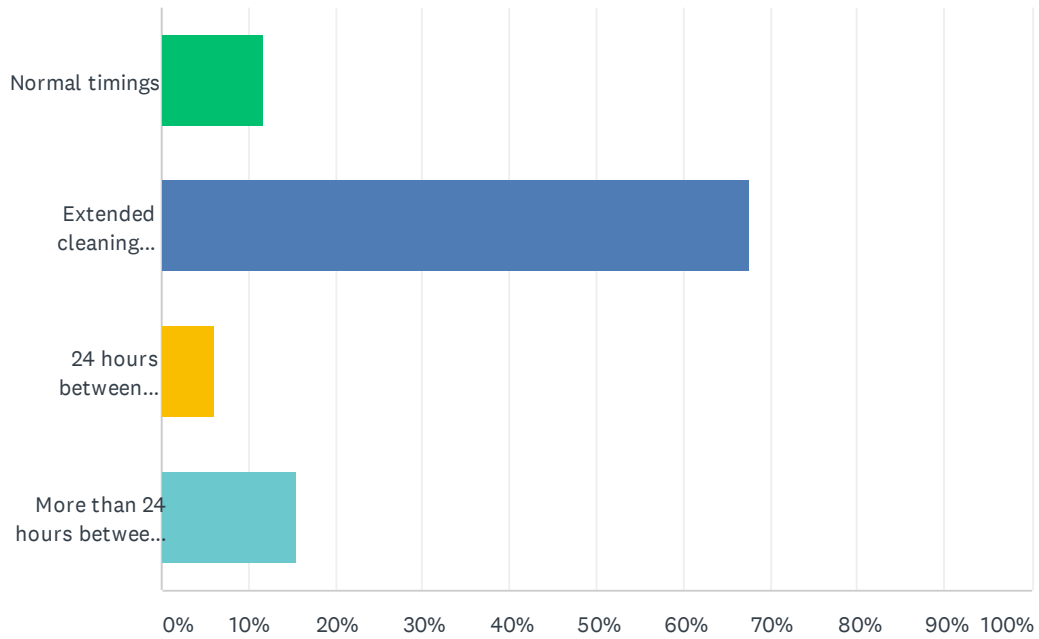
